**REGARDING:** June 23, 2020 Board Meeting and Public Hearing

On Tuesday, June 23, 2020, the Lexington County School District One Board of Trustees holds a public hearing to present the third reading of the district's 2020–2021 General Fund operating budget and to hear citizens' comments on the budget.

The meeting opens at 6 p.m. in the auditorium. The board will promptly vote to enter executive session. For this meeting, the executive session will take place in the auditorium of Building One of Central Services located at 100 Tarrar Springs Road in Lexington, South Carolina. The public hearing takes place at 7 p.m. in the same auditorium. The Board of Trustees will hold a board meeting immediately following the public hearing.

The board will put into place some special safeguards in order to comply with the Governor's orders and CDC COVID-19 recommendations regarding social distancing and other precautions. The auditorium will be thoroughly cleaned and sanitized before and after the board meeting. District staff will also sanitize the microphone before and after staff presentations or individuals speaking during Citizens' Participation. Board members will take part in social distancing by maintaining a safe social distance from any other board member. All board members, employees, or other individuals attending the meeting in person are encouraged to wear a cloth face covering (mask) at all times. There will be limited seating. Once that seating is filled, attendees will be asked to go to the Staff Development Room/Overflow Room, where they can watch the meeting while also observing social distancing guidelines.
