Council to Provide First Reading of AN ORDINANCE TO AMEND CHAPTER 33 OF THE YORK COUNTY CODE OF ORDINANCES SECTION 33.119(A) TO CLASSIFY THE EMPLOYMENT STATUS OF PAID STUDENT INTERNS, PROVIDE FOR DRUG SCREENINGS, ASSIGN MANAGEMENT OF THE INTERN PROGRAM TO HUMAN RESOURCES, AND CLARIFY EDUCATIONAL REQUIREMENTS FOR PAID INTERNS; SECTION 33.119(B) TO REMOVE NON-PAID STUDENT INTERNS AND PROVIDE A TIME PERIOD FOR PAID INTERNSHIPS; TO DELETE SECTIONS 33.119(C), (D), (E), AND (F) PROVIDING FOR PROCEDURES AND CRITERIA FOR UNPAID STUDENT INTERNS; TO ADD SECTION 33.120 ENTITLED VOLUNTEER PROGRAM; AND TO PROVIDE FOR OTHER MATTERS RELATED THERETO.

- 5. Council to approve the Sheriff's Office request to apply for and accept if awarded the 2021 South Carolina Department of Public Safety Traffic Grant in the amount of \$224,496. Grant consists of 100% funding, no match from York County. Grant will fund the continuing operations for the Sheriff's Office Traffic Enforcement Unit.
- 6. Council to authorize a 3-year lease agreement with Rinehart Property Management to lease space for the Clover Sheriff's District Office located at 1474 Hwy. 55 East, Suite 200 in Clover.
- 7. Council to approve the replacement/upgrade of the video security monitoring system from Stanley Convergent Security Solutions Inc. of Noblesville IN, for use by the York County Prison, for a total amount not to exceed \$97,140.00.
- 8. Council to approve award of Bid #2669 regarding the purchase of waste compaction equipment and containers for use by York County Collection & Recycling, to the lowest responsive and responsible bidder, Bakers Waste Equipment of Lenoir, NC for the total cost of \$451,035.79.
- 9. Council to approve award of Bid #2671 regarding routine electronic recyclables transportation and processing services, to Powerhouse Recycling Inc., of Salisbury, NC, for a total cost of \$151,523.00.
- 10. Council to approve the execution of an Engineering Contract with the Wooten Company of Columbia, SC for \$47,900.00, plus a 10% contingency to evaluate existing sewer pump stations in the County's Western Sewer System.
- 11. The York County Code of Ordinances §153.57(B) requires an annual report on impact fees at the first Council meeting in March. The impact fee report provides Council with all of the information required by ordinance, as well as summary data for impact fee collection in 2019.
