AN ORDINANCE OF THE CITY OF NICHOLASVILLE, KENTUCKY AUTHORIZING THE ISSUANCE OF CITY OF NICHOLASVILLE, KENTUCKY GENERAL OBLIGATION BONDS, SERIES 2020A IN THE APPROXIMATE AGGREGATE PRINCIPAL AMOUNT OF \$40,695,000 (SUBJECT TO A PERMITTED ADJUSTMENT INCREASING PRINCIPAL AMOUNT OF BONDS BY UP TO \$4,070,000 OR DECREASING THE PRINCIPAL AMOUNT OF BONDS BY ANY AMOUNT) FOR THE PURPOSES OF (A) FINANCING A PORTION OF THE REMAINING COSTS OF THE ACQUISITION, CONSTRUCTION, EQUIPPING, AND INSTALLATION OF A NEW MUNICIPAL GOVERNMENT BUILDING WHICH WILL FUNCTION AS A POLICE STATION AND FACILITY FOR OTHER CIVIC PURPOSES LOCATED WITHIN THE JURISDICTIONAL BOUNDARIES OF THE CITY; (B) FINANCING ALL OR A

PORTION OF THE COSTS OF THE ACQUISITION, CONSTRUCTION, EQUIPPING, AND INSTALLATION OF THE UPGRADE AND EXPANSION OF THE CITY'S MUNICIPAL SEWAGE TREATMENT PLANT; (C) FINANCING ALL A PORTION OF THE COSTS OF A NEW FIRE TRUCK; (D) REFINANCING THE OBLIGATIONS OF THE CITY OWED TO THE KENTUCKY INFRASTRUCTURE AUTHORITY PURSUANT TO FOUR ASSISTANCE AGREEMENTS; AND (E) REFINANCING ALL OR A PORTION OF THE CITY'S GENERAL OBLIGATION BONDS, SERIES 2011A; APPROVING THE FORMS OF THE BONDS; AUTHORIZING DESIGNATED OFFICERS TO EXECUTE AND DELIVER THE BONDS; AUTHORIZING AND DIRECTING THE FILING OF A NOTICE WITH THE STATE LOCAL DEBT OFFICER; PROVIDING FOR THE PAYMENT AND SECURITY OF THE BONDS; CREATING A BOND PAYMENT FUND; CREATING A SINKING FUND; AUTHORIZING ACCEPTANCE OF THE BIDS OF THE BOND PURCHASER FOR THE PURCHASE OF THE BONDS; AND REPEALING INCONSISTENT ORDINANCES.
