Marty Murphy, Corrections Planning Board presented. Armond Budish asked for clarification on the start date. Mr. Budish also inquired about the number of clients being served under a shorter time period as it relates to services not starting until June of Calendar Year 2017. Nan Baker asked whether funds could be recovered retroactively to the start of the FY2016 grant period; asked for confirmation that the contract began on September 30, 2016; asked if the grantor were to inquire about funding that was not requested for services during 2016 and analyze the billing and dates that reflect when the services actually occurred, will this be a cause for concern.

Ms. Baker also asked about reporting requirements; how report data will be analyzed; who will receive the report; how the County will benefit from the report findings; and asked for clarification on how the data will be utilized by the County. Mr. Budish asked for clarification on the client being served under this contract and whether funds are being used for treatment services. Dale Miller inquired about the anticipated cost of the entire treatment program; and asked if data analysis is performed locally or by Federal authorities only, as it relates to how the County benefits from the data provided. Mr. Miller commented on the high cost of treatment services and the increasing need for MAT services. Mr. Miller also stated that the County cannot fully fund the entire treatment program and encouraged a means to address the issues on the front end. Mr. Budish concurred. The Division of Senior and Adult Services (DSAS) is seeking to provide ongoing financial assistance to support an administrative assistance and public policy consultant to assist the Council on Older Persons (COOP) in meeting its mission to promote a better understanding of aging and address the issues and concerns of older persons in Greater Cleveland through citizen led needs assessment, policy development, community education and advocacy. The McGregor Foundation issued a challenge grant in the amount of \$17,500 to financially support staffing and activities of COOP. DSAS is requesting to contribute \$7,500 toward this effort. The Challenge grant will help cover the costs for staffing administrative support (up to 200 hours annually) and public policy analysis and support (up to 250 hours annually). These funds will support the salary, fringes and other expenses related to these positions.

This will help fund advocacy for senior issues on a state and local level. This challenge grant was initiated due to the lack of local funding for advocacy for senior issues. By providing funding for advocacy efforts, DSAS expects that these efforts will continue to lead to positive outcomes for senior-related budgetary decisions, including additional funding for things like meals and transportation, particularly from state funding sources. Additionally, by supporting research of senior issues, this will allow COOP to stay on the "cutting edge" of senior services when they make their recommendations for actions to be taken on the local level.

COOP is an advocacy group that was formed nearly 80 years ago, in 1940. It is the primary organization advocating for seniors in Greater Cleveland. The challenge grant by the McGregor Foundation prompted DSAS to contribute these funds to COOP.

As this was in response to a challenge grant specifically targeting COOP, it was not possible to utilize a competitive process. An exemption was pursued in order for DSAS to respond to the challenge grant. This

item has never been competitively bid because the nature of the transaction makes competitive procurement impossible.

This contract is being submitted late for a variety of unique and critical issues:

During the past month, the Office of Early Childhood moved from Courthouse Square to Quincy Place. The move was very disruptive of our operations and included not just the physical move but also a migration to the state computer/email network. The move delayed the normal processing of this contract AND delayed access to critical county systems such as FAMIS, BuySpeed on Onbase which were necessary to submit this contract.

The Office of Early Childhood has worked closely with the Law Department to revise and approve contract. Currently, there is only one attorney assigned to work with all of HHS; this is clearly not adequate and led to delays in the submission of this contract.

Per the direction of HHS leadership, all OEC contracts, including this one, must now contain outcomes, in addition to deliverables and outputs. As this is a fundamental change in the way HHS contracts are structured, substantial negotiation was required with this vendor to come to agreement on the outcomes included. This introduced delays in the processing of this contract.

Per the direction of Risk Management, this contract included additional substantial cyberinsurance coverage requirements because this vendor maintains a data system that includes personal information on children and families served by this program. These insurance requirements were new for the vendor and incurred a substantial increase in cost. These requirements needed to be negotiated and the vendor needed to make provisions to come into compliance with these new requirements, including revising the budget to pay for these increases.
