Whereas, Cincinnati City Council is committed to  
pedestrian safety and supports Neighborhoods that  
are taking action to address issues of speeding  
and safety on their streets and Whereas, the  
residents of Kroger Avenue have undertaken all  
reasonable steps to mitigate speeding and  
pedestrian safety on their street, working with  
DOTE, and that it has been determined that no  
engineering fixes are workable on a street with  
the grade, sightlines and location of Kroger; and  
Whereas the residents have circulated a petition  
that shows their desire to address the issue of  
speeding and pedestrian safety on Kroger; and  
Whereas, the residents desire stop signs to be  
placed at the corner of Kroger and Overland, and  
the Mt. Lookout Community Council has submitted a  
letter of support for such stop signs, citing,  
among other things, several near misses and the  
failure of previous street calming measures; and  
Whereas, Cincinnati City Council expressly  
supports the idea of stop signs being used for  
speed control on particularly dangerous streets  
where no other solutions are viable; and  
Therefore, WE MOVE that the Department of Traffic  
and Engineering work to install stop signs at the  
intersection of Kroger and Overland.
