CITY OF CAYCE Regular Council Meeting July 9, 2019

The July Regular Council Meeting was held this evening at 6:00 p.m. in Council Chambers. Those present included Mayor Elise Partin, Council Members Tara Almond, Phil Carter, Eva Corley and James Jenkins. City Manager Tracy Hegler, Municipal Clerk Mendy Corder, Municipal Treasurer Garry Huddle, Planning and Development Director Carroll Williamson, City Engineer Karalyn Miskie, Director of Public Safety Byron Snellgrove, Deputy Director of Public Safety Jim Crosland, Director of Human Resources Lynn Dooley, and City Attorney Danny Crowe were also in attendance.

Mayor Partin asked if members of the press and the public were duly notified of the Council Meeting in accordance with the FOIA. Ms. Corder confirmed they were notified.

Call to Order

Mayor Partin called the meeting to order. Council Member Jenkins gave the invocation. Mayor Partin led the assembly in the Pledge of Allegiance.

Approval of Minutes

Council Member Almond made a motion to approve the June 4, 2019 and the June 19, 2019 Regular Council Meeting minutes as written. Council Member Jenkins seconded the motion which was unanimously approved by roll call vote.

Public Comment Regarding Items on the Agenda

No one signed up for Public Comment.

Presentations

A. Presentation of Law Enforcement Accreditation to Cayce Public Safety by the South Carolina Police Accreditation

Mayor Partin introduced Mr. Chip Johnson, a Board member of the South Carolina Law Enforcement Accreditation Council. She stated Mr. Johnson was in attendance to present Cayce Public Safety with the Law Enforcement Accreditation certificate. Mr. Johnson stated that it was his honor to present Cayce Public Safety with their certificate. He stated that his career started at Cayce and he considers it his home. He stated that a great deal of work goes into the accreditation process and the

certificate is earned, not given away. Mr. Johnson stated that Cayce Public Safety, led by Director Byron Snellgrove, received the distinguished recognition of becoming a South Carolina State Accredited Agency. He stated that they achieved accreditation in record time. He stated that the accreditation team that came to Public Safety to review the Department's practices, procedures and policies had some of the most positive comments about the Department that Mr. Johnson has read since he has been on the Accreditation Council. He stated that the staff at Cayce Public Safety were prepared and their sole focus was on providing the best services to the citizens of Cayce.

Mr. Johnson stated that there are approximately 250 municipal police agencies in the state and only 25 of these agencies have achieved accreditation. He stated that Cayce is an agency that other agencies are looking to follow. He stated that as difficult as it is to become an accredited agency it is even more difficult to be reaccredited. He stated that the accreditation is monitored annually and every three (3) years the Cayce Department of Public Safety will go through the reaccreditation process. Mr. Johnson stated that in the initial accreditation process Public Safety staff set the standards that they want to achieve. He stated that in the reaccreditation process every occurrence in the past three (3) years that required that standard has to be documented and each of those files will be reviewed.

Mr. Johnson stated that Public Safety has made a huge commitment to be an accredited agency but they will need Council's commitment for them to continue to be reaccredited. He stated that it is a partnership with the City and Council and Public Safety will need Council's support and funding to continue. He stated that it is not easy to maintain accreditation and it was intentionally made to be difficult to set a high standard of professionalism. He stated that the City's residents will benefit greatly from having an accredited Public Safety Department. Mr. Johnson stated that Cayce is even more exceptional because the men and women in the department are not just police officers but also certified fire fighters. He stated that Cayce Officers perform two (2) jobs and have to maintain certifications for both careers.

Mr. Johnson stated that Cayce Public Safety is one of the only agencies that he is aware of that does not have any vacancies. He stated that people are waiting to come work at the Cayce Public Safety Department which is unheard of. He stated that other agencies will now come to Cayce to see how they achieved accreditation. Cayce Officers will also go to other departments to access their standards and will learn from those departments as well.

Mr. Johnson presented Chief Snellgrove with the South Carolina Law Enforcement Accreditation certificate. Chief Snellgrove stated that every person in the Department helped with the accreditation process. He stated that in his opinion he has the best department in the state.

Mayor Partin thanked Mr. Johnson for his presentation and stated that being an accredited agency is a major accomplishment and Council appreciates the initiative of every Officer for going through the long and tedious process, for studying and reviewing the policies and for going above and beyond. She stated that not only is being an accredited agency an important benchmark for the City but it also earns the City bonus points on the South Carolina Municipal Insurance and Risk Financing fund rating. She stated that Public Safety's hard work has monetary benefits for the City as well.

Mayor Partin thanked Chief Snellgrove and Deputy Director Crosland and the accreditation team, Captain of Police Services Jimmy Gleaton, Administrative Lt. Paul Dufault, Investigative Sgt. Jason Merrill and Master PSO Jacob Harlow for their hard work. She stated that they oversaw the process without complaint and in addition to their regular daily duties. She stated that Council was very proud of them.

Resolutions

A. Approval of Resolution Recognizing Dr. Shirley McClerkin-Motley's Accomplishments and Retirement

Council Member Jenkins made a motion to approve the Resolution recognizing Dr. McClerkin-Motley's many accomplishments and her retirement. Council Member Corley seconded the motion which was unanimously approved by roll call vote. Council Member Jenkins stated that at one time Dr. McClerkin-Motley was also the head of the Julius Felder Coalition.

Ordinances and Other

A. Discussion and Approval of Ordinance 2019-11 Re-Zoning 800 Lexington Avenue (TMS# 005769-04-001), 800A Lexington Avenue (TMS# 005769-04-004), and 1815 8th Street (TMS# 0057659-04-002) from RS-3 (Single Family Residential) to RS-4 (Single-Family Residential) – First Reading

Ms. Hegler stated that Council approval was needed for the First Reading of an Ordinance to re-zone 800 Lexington Avenue (TMS# 005769-04-001), 800A Lexington Avenue (TMS# 005769-04-004), and 1815 8th Street (TMS# 005769-04-002) from RS-3 (Single Family Residential) to RS-4 (Single-Family Residential). She stated that the rezoning request includes three properties zoned RS-3 Single Family Residential. The largest parcel at 800 Lexington Avenue is 1.52 acres and is owned by Broad Brook-CT LLC, who is the primary applicant. She stated that the applicant is also serving as the agent for the property owner at 1815 8th Street. Because the applicant is required to have a minimum of 2 acres to rezone property to a zoning district that is not contiguous to this property, the City was asked to allow its adjacent parcel at 800A Lexington Avenue be part of the rezoning request to meet the two (2) acre threshold. Ms. Hegler

stated that the one structure, the former Cayce Grammar School, is located at 800 Lexington Avenue and is approximately 6,087 square feet. The parcel at 800A Lexington Avenue is vacant and a single family residence is located at 1815 8th Street.

Ms. Hegler stated that the rezoning does not result in any change of uses from RS-3 Single Family Residential to RS-4 Single Family Residential. However, some lot dimensions and setbacks do change. She stated that the minimum lot size is reduced from 7,200 square feet to 5,000 square feet. The minimum lot width is reduced from 60 feet to 50 feet. The rear yard setback is reduced from 20 feet to 15 feet. Many of the surrounding lots currently have a lot width of 50 feet. The minimum side setback of five (5) feet remains the same, as well as the minimum front setback of 25 feet. Ms. Hegler stated that the requested re-zoning is in compliance with the Zoning Ordinance and is permitted as a zoning district in accordance with the criteria of the Comprehensive Plan and Future Land Use Map.

Ms. Hegler stated that the Planning Commission considered the request for rezoning at the meeting on June 17, 2019. The hearing for the rezoning request was opened to the public. Two members of the public spoke against the re-zoning request because of their concern about the smaller lot sizes and the close proximity of the houses to each other. Two members of the public spoke in favor of the re-zoning, citing the potential for new housing in the area. The Planning Commission voted on the requested re-zoning, to the RS-4 zoning designation, at the Planning Commission Meeting on June 17, 2019.

Council Member Almond made a motion to approve Ordinance 2019-11 on First Reading. Council Member Corley seconded the motion which was unanimously approved by roll call vote.

City Manager's Report

Ms. Hegler stated that the Municipal Association of South Carolina's annual meeting was being held July 18 through July 21 in Greenville. She stated that Council and staff were holding a Strategic Planning Session in Greenville on July 17, 2019 at 9am. She asked Council to come prepared to have fun and think creatively with all the City Departments. She stated that the Census Bureau would be hosting a hiring event at City Hall on July 12 from 10am to 3pm. These jobs are temporary, provide great pay and flexible hours.

Council Member Corley stated that she thought her heart was going to burst with pride during Mr. Johnson's presentation to Public Safety. She congratulated them again on such a huge accomplishment. Mayor Partin stated that Mr. Johnson's presentation was very heartfelt.



Subject: Discussion and Approval of Hospitality Tax Grant Funding for Fiscal Year 2020

Issue

City Council approval is needed to utilize Hospitality Tax funds to award grants during the 2020 fiscal year.

Discussion

Grant Requests

The City received 11 Hospitality Tax Fund grant requests totaling \$138,775. Applications were accepted from April 22nd to May 31st, 2019. Requests were made for grant funding for events and/or projects taking place during fiscal year 2020.

Hospitality Tax Revenues:

As of July 23, 2019, the City had a Hospitality Tax Fund balance of \$675,840. In fiscal year 2019, revenues collected total \$1,204,995.33. Based on this revenue, staff projects a FY20 total Hospitality Tax revenue collection of at least \$1,250,000.

Hospitality Tax Expenditures:

During this fiscal year, the City budgeted \$839,905 in Hospitality Tax Funds for fiscal year 2020 operation and maintenance of tourism-related activities and capital items. Staff also recommends holding back \$167,200 for hospitality tax projects related to the 12,000 Year History Park, Arts District Development and a Citywide Wayfinding Plan, in the fund balance as designated reserve.

2019-20 projected revenue \$1,250,000 Budgeted transfer to FY20 operation and maintenance / - \$839,905

capital items

Hold in reserve - \$167,200 Eligible for grant making or undesignated fund balance \$242,895

Recommendation

Staff recommends Council hold back \$167,200 in the fund balance as reserve and approve staff's suggested levels for grants. Staff recommends making 10 grant awards for FY2020 totaling \$86,500, as listed below. Staff recommends accepting an application from the Cayce Arts Guild at the time when a specific event has been planned. State law does not allow hospitality tax funds to be used for the rental or purchase of a year-round facility.

Council may approve, deny or reduce any of the grant requests and/or the reserve amount.

Subject: Raw Water Intake Facility Standby Generator Project

Issue

Consideration of bid award for replacement of the existing generator located at the raw water intake facility.

Background/Discussion

During the 2015 flood, power failed to the existing generator. The generator had to be turned on manually and access at the time was by boat only. SCE&G could not access the power line and the generator almost ran out of diesel fuel after three (3) days. The City had to borrow a high profile truck from the National Guard to refuel the generator. This FEMA grant is for a new, larger-capacity backup power generator with a new automatic transfer switch providing an automatic transfer of power from the electric grid to the generator in the event that the facility loses power from the standard electric grid. This will be located at the site of the current generator and will exceed the 500-year floodplain requirements.

American Engineering Consultants, AEC, is the design engineer for this project, as approved by City Council on October 2, 2018.

Plans, specifications and requests for proposals were sent to seven (7) companies for the referenced project. Five (5) packages were received by City staff. The proposals as received are listed below:

The company with the lowest, most responsive proposal, for the requested work, is AAA Utility and Construction, LLC at \$532,000.00.

The project will receive 75% funding from a FEMA grant. The grant requires a 25% match from the City's Utility Fund, which is approved within the FY20 budget.

Work is expected to start soon upon Council approval. A 180-day project time (substantial completion) is anticipated.

Staff Recommendation

Staff recommends that City Council award the project to AAA Utility and Construction, LLC in the amount of \$532,000.00 and authorize the City Manager to execute the related agreement.
