Re: Gateway Overlay District

Over the past few months, and as part of the City Council/Planning Commission's Action Agenda, the Commission has been discussing a "gateway" or "corridor" overlay which would focus on improving the aesthetic appearance of properties along major transportation corridors leading into the historic Aiken grid system.

At the previous Planning Commission worksessions, staff was requested to present an example of how an overlay could be incorporated into the existing ordinance. There are essentially two primary means of incorporating overlay district regulations. The first is inclusion of process into the Overlay chapter of the Zoning Ordinance, and reference to a stand-alone policy document. This is the method used for the Old Aiken and Historic Overlay Districts. Alternatively, a second option would be to include the guidance regulations directly into the Zoning Ordinance rather than a stand-alone document.

Staff will be prepared at the meeting to discuss the process of considering an overlay district.
