#### **ORDINANCE # 9-2020**

ORDINANCE ORDERING A REFERENDUM AT WHICH THE QUESTION OF THE SALE OF NOT EXCEEDING \$13,900,000 GENERAL OBLIGATION BONDS OF THE CITY OF HANAHAN, SOUTH CAROLINA, SHALL BE SUBMITTED TO THE OUALIFIED REGISTERED ELECTORS OF THE CITY OF HANAHAN.

WHEREAS, the City Council ("City Council") of the City of Hanahan (the "City") has determined the need for the acquisition, construction, equipping, and furnishing of park and recreational facilities (the "Project") within the City as more particularly described in the attached Exhibit A; and

WHEREAS, the estimated cost of this acquisition, construction, equipment and furnishings is not expected to exceed \$13,900,000; and

WHEREAS, it will be necessary for the City to issue bonds for the funding of this Project; and

WHEREAS, City Council has determined that a referendum is the best procedure for the issuance of these bonds, and,

WHEREAS, §5-21-210, et seq. of the Code of Laws of South Carolina 1976, as amended authorizes a referendum for the issuance of general obligation bonds:

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HANAHAN, SOUTH CAROLINA, AS FOLLOWS:

## **SECTION 1**

At the general election to be held on November 3, 2020 there will be submitted to the qualified registered electors of the City of Hanahan the following question:

Shall the City Council of the City of Hanahan be authorized to issue and sell, in one or more series, not exceeding \$13,900,000 of general obligation bonds, in order to obtain funds for the acquisition, construction, equipping, and furnishing of park and recreational facilities to be located within the city limits of the City of Hanahan.

## **SECTION 2**

The Notice of the Holding of the Election attached to this Ordinance as Exhibit B shall be published in the Post and Courier, a newspaper of general circulation in the City of Hanahan, on or before Monday, October 19, 2020 and again within the week prior to the election.
