

contractors are added later on, the original and one copy of the additional Copermittee or contractor certifications must be submitted along with the monthly reports or copies of the inspection forms submitted after the signing of the certification. For construction Sites that disturb less than 10 acres, the Owner/Operator of the facility covered by this permit shall make all contractor certifications available to DHEC and the SWCD upon request. The Department and/or SWCD may on a case-by-case basis require the submittal of the Copermittee and other contractor certifications.

3.11 OTHER AUTHORIZATION OR REQUIREMENT

Where any authorization, bonds, permits or other securities are required by applicable federal, state or local laws, regulations or ordinances for any part of the proposed work to be done under the plan, the applicant shall, upon request, furnish the Sumter County Soil and Water Conservation District with satisfactory evidence that such requirements have been met before the commencement of work under an approved application.

3.12 EXTENSION OF TIME

If the applicant is unable to complete the work within the time specified in the approved plan and grading permit, he may, prior to the expiration of such time, present in writing a request for an extension of time, setting forth the reasons for the requested extension. The Sumter County Soil and Water Conservation District shall respond to this request within 10 working days of submission.

3.13 RESPONSIBILITY OF APPLICANT

The applicant shall be responsible for carrying out the proposed work in accordance with the approved erosion and sediment control and storm water management plan and grading permit, and in compliance with the requirements of this ordinance.

3.14 APPEALS AND ADMINISTRATIVE HEARINGS

A. The City Council of the City of Sumter shall appoint a five-member appeals board to carry out the provisions of this section. The appeals board shall be constituted as follows, and shall serve staggered three-year terms:

two grading contractors, or persons who have experience in grading or similar field;
one designer meeting the requirements of Section 3.9.G of this ordinance
two members at large

In order to provide continuity in the composition and operation of this board, the initial appointments of the grading contractors referenced above shall be one such contractor for an initial one-year term, and one such contractor for an initial two-year term. The designer referenced above shall be appointed for an initial one-year term. Upon expiration of such initial terms, the appointments thereafter shall be for three-year terms.

The City Engineer or City Director of Public Works, and the County Engineer or County Director of Public Works, shall serve ex officio, as advisory, non-voting members of the board.

The appeals and hearings board shall select a chairperson at its inception; the chair shall
