ORDINANCE NO. 2594

(Amending Ordinance Nos. 1838, 2286, 2297, 2473, 2477, and 2580)

AN ORDINANCE TO AMEND THE CITY OF SUMTER WATER AND SEWER RATES TO INCLUDE A FEE FOR DAMAGE TO METERS

- whereas, the City of Sumter, South Carolina (the "City") imposes fees and charges for utility service, including without limitation minimum, volumetric, and strength-based rates for water and sewer; connection fees for water and sewer; and administrative fees for delinquency processing and tampering (collectively, "Water and Sewer Fees");
- WHEREAS, with respect to the Water and Sewer Fees, Section 98-93 of the City Code, last amended by Ordinance 2580 of 2017, provides penalties and miscellaneous fees for delinquency and tampering;
- WHEREAS, the City is authorized by S.C. Code § 5-31-670 to "furnish water to persons for reasonable compensation and charge a minimum and reasonable sewerage charge for maintenance or construction of such sewerage system," pursuant to which it has established the Water and Sewer Fees;
- WHEREAS, the City Council of the City (the "City Council") has determined, as a fact and after appropriate investigation, that the City incurs substantial costs in repairing and/or replacing meters that have been damaged by customer or third-party action; and
- WHEREAS, the City Council has therefore determined to amend Section 98-93 of the City Code to allow the City to recover such costs;

NOW THEREFORE, CITY COUNCIL HEREBY ORDAINS, IN REGULAR MEETING DULY CALLED AND NOTICED, as follows:

- 1. Section 98-93 of the City Code, "Penalties and miscellaneous fees," is hereby amended by adding the following subsections (d) and (e) to the end thereof:
 - (d) The fee charged for repairing or replacing a damaged meter (including any associated equipment and infrastructure) shall be equal to the actual costs incurred in repairing or replacing such damaged meter, equipment, and/or infrastructure, subject to a minimum fee of \$50. This fee shall apply to any unintentional, negligent, or intentional damage caused by the customer or a third party, including without limitation damage caused by vehicles, yard equipment, soil disturbing activities, or misuse. The City, upon investigation, may waive such fee in its reasonable discretion.
 - (e) Each customer of the system shall have an affirmative duty promptly to report meter damage to the City. The failure to report such damage may be

considered as a factor in determining whether to waive the fee for repairing or replacing a damaged meter.

2. This ordinance shall become effective immediately.
