ORDINANCE NO. 2595

AN ORDINANCE DECLARING THE CLOSURE OF TWO ALLEYWAYS ON THE NORTHERN SIDE OF DINGLE STREET (BETWEEN S. SUMTER STREET AND S. MAIN STREET) AND AUTHORIZING THE TRANSFER OF SUCH ALLEYWAYS TO PRIVATE OWNERSHIP BY QUITCLAIM DEED

WHEREAS, Job's Mortuary Inc. (the "Owner") owns a parcel of land located on the northern side of Dingle Street (between S. Sumter Street and S. Main Street) and bearing Tax Map Parcel No. 22-7-04-01-069 (the "Job's Mortuary Parcel");

WHEREAS, the Sumter County tax maps indicate an alleyway on either side of the Job's Mortuary Parcel, which alleyways currently serve no public purpose or function and are unimproved (the "Alleyways");

WHEREAS, the location of the Alleyways is indicated on the attached map;

WHEREAS, the Owner has petitioned the City of Sumter, South Carolina (the "City") to close the Alleyways and to convey the City's interest in the Alleyways, if any, to the Owner;

WHEREAS, City staff has investigated the Alleyways and has determined to recommend that the petition be granted;

WHEREAS, the City published notice of a public hearing to be held on January 2, 2018, to consider the closure of the Alleyways in *The Item* on December 12, 19, and 26, 2017;

WHEREAS, the City posted notice of the proposed closings and the public hearing on the Alleyways;

WHEREAS, the City notified surrounding property owners of the proposed closings and the public hearing;

WHEREAS, the City conducted the public hearing as advertised on January 2, 2018, at 6:00 p.m.;

WHEREAS, the City Council of the City of Sumter (the "Council") has now determined, following the public hearing, that the Alleyways are no longer necessary or required for the convenience, public use, or improvement of the City; that closing the Alleyways will serve a public purpose and will be in the public interest by supporting an existing commercial development; that closing the Alleyways will not negatively affect the community or surrounding property owners and that there are other nearby routes available to emergency vehicles and the public which travel this area of the City; and

WHEREAS, the Owner, in consideration of the payment of One Dollar (\$1.00), has requested that the City quitclaim all of the City's interest in the Alleyways to the Owner;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City, as follows:

Section 1. Pursuant to Section 5-27-150 of the South Carolina Code of Laws of 1976, as amended, the City Council declares that the Alleyways are hereby closed and abandoned.

Section 2. The City shall convey the Alleyways by quitclaim deed to the Owner in consideration of the payment of One Dollar (\$1.00).

Section 3. The quitclaim deed shall be in such form and substance as may be approved, and shall be executed and delivered on behalf of the City, by the City Manager.


