**RESOLUTION NO. 515**  
**(Amending Resolution No. 419 to Extend the Term of**  
**One Additional Member of the Downtown Sumter Committee)**

**A RESOLUTION EXTENDING THE TERMS OF MEMBERS  
OF THE DOWNTOWN SUMTER COMMITTEE AND  
THE COMMUNITY DEVELOPMENT HOUSING BOARD  
OF THE CITY OF SUMTER, SOUTH CAROLINA**

- WHEREAS,** the City Council (the "Council") of the City of Sumter, South Carolina (the "City") has previously established a Downtown Sumter Committee and a Community Development Housing Board, both of which are primarily advisory boards that provide invaluable assistance and guidance in the City's activities in their respective areas;
- WHEREAS,** Section 2-164(1) of the City's Code of Ordinances (the "Code") provides the maximum tenure for membership on a board or commission of the City;
- WHEREAS,** according to the terms of said Section 2-164(1) of the Code, there are currently three members of the Downtown Sumter Committee (*viz.*, Hubert Osleen, Jr., Angus McDuffie, and Emma Singleton) and one member of the Community Development Housing Board (*viz.*, Dollie Swinton) who have reached their maximum tenure (such individuals being referred to collectively as the "Members");
- WHEREAS,** *Jay Davis has reached his maximum tenure on the Downtown Sumter Committee, and City Council (on this 6<sup>th</sup> day of September, 2011) wishes to add his name to the list of Downtown Sumter Committee members in the paragraph above for extension of the maximum tenure; and*
- WHEREAS,** Section 2-164(2) of the Code allows the City Council of the City (the "Council") to amend such maximum tenure in "extreme, extenuating, peculiar and unusual circumstances;"
- WHEREAS,** the Members have served faithfully and diligently, and the Council has determined that the City, the Council, and the greater Sumter community would substantially benefit from the continued service of the Members; and
- WHEREAS,** in light of the advisory nature of the Downtown Sumter Committee and the Community Development Housing Board, and the invaluable and dedicated service of the Members, the Council has determined it to be in the best interests of the City and its residents for the Council to extend the maximum tenure of the Members pursuant to Section 2-164(2) of the Code.


**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF SUMTER, SOUTH CAROLINA, AS FOLLOWS:**


1. In light of the recitals contained above, the Council hereby determines that the maximum tenure of the Members, if they be willing to serve, shall be extended pursuant to Section 2-164(2) of the Code. With respect to Members who consent to continue to serve, there shall be no maximum tenure for service on either the Downtown Sumter Committee or the Community Development Housing Board.
2. The Council hereby declares that the facts contained in the recitals to this Resolution constitute "peculiar" and "unusual" circumstances, and therefore find as a fact that the conditions to said Section 2-164(2) have been satisfied.

contractors are added later on, the original and one copy of the additional Co-permittee or contractor certifications must be submitted along with the monthly reports or copies of the inspection forms submitted after the signing of the certification. For construction Sites that disturb less than 10 acres, the Owner/Operator of the facility covered by this permit shall make all contractor certifications available to DHEC and the SWCD upon request. The Department and/or SWCD may on a case-by-case basis require the submittal of the Co-permittee and other contractor certifications.

## 3.11 OTHER AUTHORIZATION OR REQUIREMENT

Where any authorization, bonds, permits or other securities are required by applicable federal, state or local laws, regulations or ordinances for any part of the proposed work to be done under the plan, the applicant shall, upon request, furnish the Sumter County Soil and Water Conservation District with satisfactory evidence that such requirements have been met before the commencement of work under an approved application.

## 3.12 EXTENSION OF TIME

If the applicant is unable to complete the work within the time specified in the approved plan and grading permit, he may, prior to the expiration of such time, present in writing a request for an extension of time, setting forth the reasons for the requested extension. The Sumter County Soil and Water Conservation District shall respond to this request within 10 working days of submission.

## 3.13 RESPONSIBILITY OF APPLICANT

The applicant shall be responsible for carrying out the proposed work in accordance with the approved erosion and sediment control and storm water management plan and grading permit, and in compliance with the requirements of this ordinance.

## 3.14 APPEALS AND ADMINISTRATIVE HEARINGS

- A. The City Council of the City of Sumter shall appoint a five-member appeals board to carry out the provisions of this section. The appeals board shall be constituted as follows, and shall serve staggered three-year terms:

- two grading contractors, or persons who have experience in grading or similar field;
- one designer meeting the requirements of Section 3.9.G of this ordinance
- two members at large

In order to provide continuity in the composition and operation of this board, the initial appointments of the grading contractors referenced above shall be one such contractor for an initial one-year term, and one such contractor for an initial two-year term. The designer referenced above shall be appointed for an initial one-year term. Upon expiration of such initial terms, the appointments thereafter shall be for three-year terms.

The City Engineer or City Director of Public Works, and the County Engineer or County Director of Public Works, shall serve *ex officio*, as advisory, non-voting members of the board.

The appeals and hearings board shall select a chairperson at its inception; the chair shall
