THIS LEGALLY BINDING AGREEMENT made and concluded in the County and State aforesaid by and between the City of Walterboro, a municipal corporation hereinafter known as the Seller, and Strait Lyle and or his Assignee hereinafter known as the Purchaser.

WITNESSETH:

That the Seller agrees to sell and the Purchaser agrees to buy, subject to the rights of the tenants, if any, the real estate described as follows, in "AS IS CONDITION" upon the terms and conditions set forth below.

DESCRIPTION OF PROPERTY:

Two Lots located on Moore Street in the City of Walterboro, in Colleton County, South Carolina which are shown on the tax maps for Colleton County as TMS # 163-15-00-069.000 and TMS # 163-15-00-068.000.

PURCHASE PRICE:

The purchase price is Ten Thousand and 00/100 Dollars (\$10,000.00) and is to be paid in full to Seller at closing.

TERMS AND CONDITIONS OF SALE:

The parties hereto agree that all taxes and rents upon the real estate levied or to be levied in the calendar year in which deed is delivered, be prorated to date of delivery of deed as if levied for the calendar year in which deed is delivered.

Possession of said premises will be given Purchaser on closing.

Said property is being sold in "AS IS" condition and purchased subject to zoning ordinances and regulations; building restrictions; and conditions, restrictions and easements of Public Record.

Seller agrees to deliver good and marketable or insurable title to the property above described and title is to be conveyed by a good and sufficient limited warranty deed free and clear of all encumbrances. Should Seller's title to the property not prove to be good and marketable or insurable, then Purchaser may choose to close and receive a deed to such interest as Seller may have in the property or cancel this transaction and receive a refund of his escrow deposit.

Purchaser agrees to pay all costs of this transaction normally paid by Purchaser and Seller, including, but not limited to, state and county documentary stamps or other deed recording fees and preparation of the deed.

This transaction shall be closed, the moneys due to Seller shall be paid, and all documents signed by the parties hereto on or before November 6, 2020 (the closing date).

Purchaser agrees to place the sum of Five Hundred and 00/100 Dollars (\$500.00) in escrow with Purchaser's real estate broker, to wit: Coldwell Banker Todd Land Agency on account of the purchase price of the above described property, with two (2) days of the date the last party to this Contract of Sale signs it. Said deposit is to be held in escrow by said broker pending closing. It is expressly agreed that upon the event of any default or failure on the part of the Purchaser to comply with the terms and conditions of this contract, that one-half of said deposit is to be paid to the said broker not to exceed the commission due and the remaining portion of said escrow shall be paid to the Seller as liquidated damages; said deposit, however, to be refunded to the purchaser should the purchaser choose not to close under the terms of this Contract of Sale.

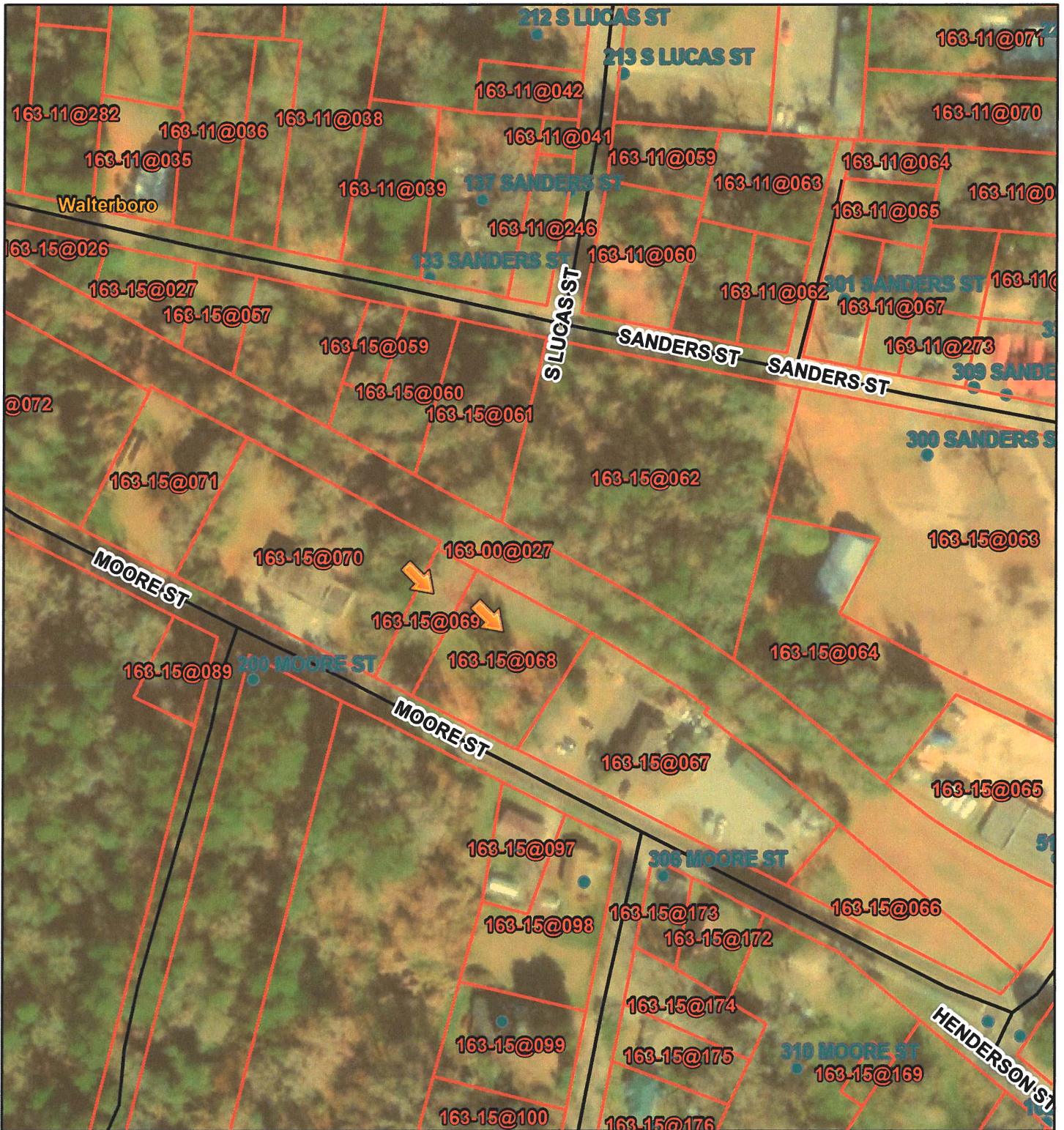

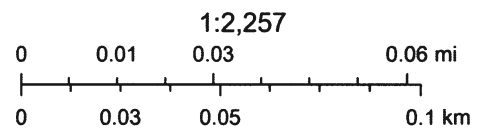

Dear Ms. Risher;

For all, but not part, of the \$236,143.50 tax exempt lease purchase financing for the acquisition of a 2020 Freightliner garbage truck as more fully described in the attached Request for Proposal (RFP), which is, by reference, hereby made a part of this bid, we will fund \$236,143.50.

Term: Issue date on or about October 1, 2020. As described in the RFP, the Note will have five (5) annual principle plus accrued interest payments due on October 1 of each year beginning October 1, 2021 until maturity or prior redemption. All outstanding principle and interest due October 1, 2025.

Rate: Bank Qualified Tax Free rate equaling 1.43%. Rate shall be fixed for the duration of the term.

Payment: Annual payments of principle and interest shall be due and payable beginning on October 1, 2021 and continuing annually thereafter until paid in full. Interest component of payments to be calculated on a 30/360 basis.

Fees: None will be paid to or on behalf of the Bank. This includes the initial closing of the Agreement and on an annual basis. All fees incurred by the City's Bond Counsel and associated with the document preparation and closing of this note will be the responsibility of the City.

Requirements: It is understood that the City's Bond Counsel will prepare documents to be reviewed by Bank and its counsel. The legal opinion of bond counsel satisfactory to Bank that the Note constitutes a valid and binding obligation of Borrower; will be "Qualified Tax Exempt Obligation" within the meaning of Section 265 (b)(3)(B) of the Internal Revenue Code of 1986, as amended; and will be exempt from all Federal, State, County, and Municipal taxes.

Acquisition/Escrow Account: Funds will be deposited into an interest bearing account at South State Bank unless the funds have already been spent and equipment acquired.

We acknowledge that the City may reject any and all proposals as well as negotiate with the lowest responsible proposer. We acknowledge that we may not alter, modify, or withdraw our bid after we have submitted it to the City.

We acknowledge that the aggregate principle amount is subject to adjustment, both before and after the receipt and opening of sealed bids for their purchase. We acknowledge that the dollar amount bid for the principle by the successful bidder may be adjusted to reflect and reduction in the aggregate principle amount of the Agreement, but the interest rate specified by the successful bidder for the Agreement will not change.

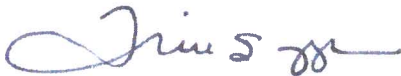

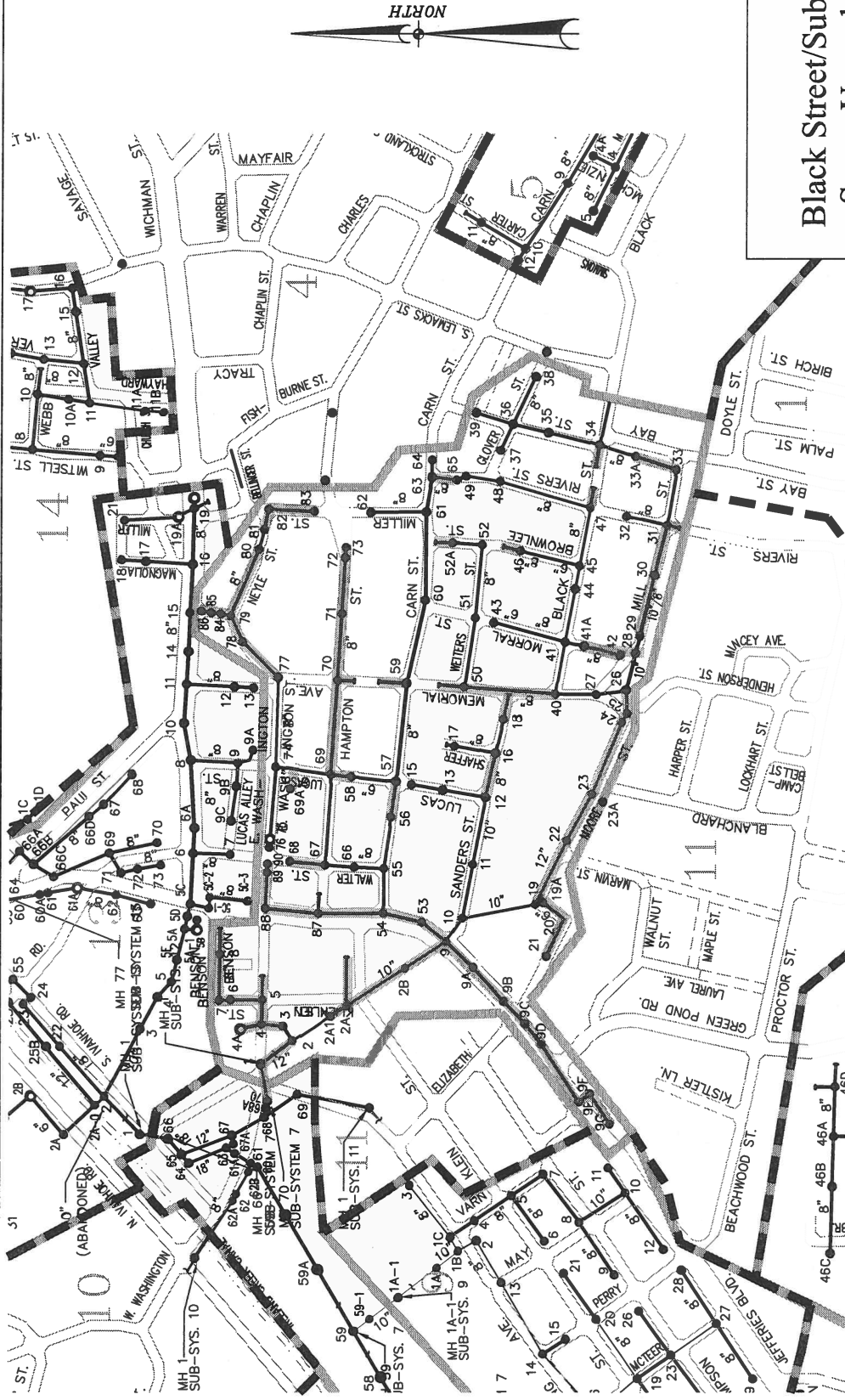
