Virtual Meeting

CALL TO ORDER

PLEDGE OF ALLEGIANCE

Committee Chairman Sommerville led the Pledge of Allegiance.

APPROVAL OF MINUTES: AUGUST 27, 2020

Motion: It was moved by Council Member Dawson, seconded by Council Member Howard to approve the minutes from August 27, 2020. The vote: Unanimous without objection. The motion passed. 10:0

PRESENTATION FROM SUPERINTENDENT FRANK RODRIGUEZ

Council Member McElynn introduced Superintendent Frank Rodriguez.

Dr. Rodriguez stated at they began the year in a virtual format and what is important is regardless of what day face to face instructions start, that there are 47% of families that chose a virtual format for the year.

Council Member McElynn mentioned that there a lot of community partners that have called to help families that need assistance with additional supervision while parents work.

Council Member Hervochon asked Dr. Rodriguez if the school district has a reserve fund to utilize for programs like this.

Dr. Rodriguez stated that there are partnering with organizations like this but are not using their reserve funds for funding.

Council Member Glover brought forth his concern with the rural community not being able to use virtual learning because they do not have access to the internet.

Dr. Rodriguez stated that there are a couple of opportunities out there through the legislative body and one is securing a device that is similar to a hotspot and that the school district has gone through the process of securing those devices and have 2,400 on hand. An application process with income criteria, secures this device and have had 200 applicants that have been provided with a device. Secondly, internet providers may submit a proposal to the state to provide broadband access to an area and in turn, recoup the money they spent on it from the state. Hargary has submitted four proposals for the Beaufort area.

Council Member Glover asked if there were any student loss in the rural community because they cannot receive internet service.

Dr. Rodriquez stated that they haven't lost any students that have tried to engage. The transportation team has been enlisted with placing phone calls to the students who are not actively participating or failing to engage to make sure they participate.

Council Member McElynn mentioned that the County is making every effort they can to provide access to building for elementary and middle school students so that they may have internet access and adult supervision.

Council Member Rodman stated that he thinks that the school district is in a position to let the County know what the needs are to help the students and believes that the need is greater than what the Council is asking for.

UPDATE FROM COUNCIL MEMBER LARRY MCELYNN

Council Member McElynn relayed the following statement of information.

The community services department will soon be considering grant requests from community groups to fund certain aspects of their ongoing activities. Several community groups have organized to engage in distance learning as the new school year starts and as the school district is operating with restrictions in place due to COVID he anticipates 3-4 groups will seek assistance with distance learning needing \$40,000.00 to \$50,000.00 in each case. Grants are also being requested by those organizations from a variety of different funding sources. He is not sure of the number of groups that will eventually submit applications to the Community Services Department but believes that they have the chance to support the board of education in their efforts to support and encourage meaningful distance learning and allow adequate physical distance learning in the public school buildings. The County should be prepared to provide as much community assistance and support as needed. Over 40 organizations have requested for \$750,000.00 in community grants applications and the amount of money available is currently \$398,000.00. Only two applications are from organizations that are able to provide assistance with distance learning and he would like to see those applications pulled from the pool of applicants for community service grant funding and fund them with money from the general reserve fund. Even though there are only two applicants at this time when people become aware that the County is interested in forming a partnership with the board of education we may have more people asking for funds. These applicants need to be researched if any other funding has been applied for and if so only make up for the shortfall from any other grants being awarded.

Council Member McElynn would like to move this in the form of a motion.

Motion: It was moved my Council Member McElynn, seconded by Council Member Passiment to forward this matter to finance committee for the consideration of taking up this matter up as a potential grant opportunity with a commitment of up to \$200,000.00 from the general reserve fund. The vote: Unanimous without objection. The motion passed. 10:0.
