DISCUSSION ITEMS

Greenprint Update

Chairman Mathews introduced members of Design Workshop which is the consultant that was hired by Beaufort County to help develop the Comprehensive Plan and the Greenprint. Members included Mr. Glenn Walters, Mr. Kurt Culbertson, Ms. Emily McCoy, and Ms. Lindsey Naylor. Mr. Walters stated that Design Workshop recently held two virtual stakeholder meetings with the public to gather input. During the meetings they asked the public to weigh in on items important to the Rural and Critical Land Preservation Program by participating in a live survey. Design Workshop then made the survey available online until September 14, 2020. Mr. Walters stated they are currently compiling the data and will have a report to the R&C Board for review by October 30, 2020 and hopefully a final Greenprint document by December 17, 2020.

Update on Longwood Conservation Easement and 2020A Port Royal Island Battlefield

Mr. Greenway stated that the County has finished all of the due diligence for the Longwood Conservation Easement to be purchased. The County was waiting on the seller to provide that last documentation needed to close the project.

Mr. Greenway also stated the County had finished all due diligence for project 2020A Port Royal Island Battlefield but were waiting on a fence encroachment to be removed off of the property. Once that was accomplished, the property would be closed.
