PRIOR BOARD ACTION	The site plan for these projects was developed as part of the recent W.B. Wicker Elementary School bond. The Board took action to reject the original bid submissions for Phase 1 of the Parks Project at the meeting on August 17, 2020 due to all bids coming in significantly over budget.

Following some revisions to the bid specifications, a new bid opening was held at 2:00 p.m. on September 22, 2020. Following the bid opening and review by the project engineering firm, Withers Ravenel, JM Thomson was identified as the lowest responsive responsible bidder. Bids were received from: JM Thomson Cary, NC \$1,818,500 Fred Smith Company Raleigh, NC \$2,325,800 BAR Construction Company Greensboro, NC \$2,334,210 Sanford Contractors Sanford, NC \$2,398,830 Park Project Summary Horton Park Phase 1 - Total = \$339,000 -

PRIOR BOARD ACTION	Mosely Architects was hired on October 20, 2017 to conduct a space needs study. The Board approved the contract with BAR Construction for renovations to the Government Center, Courthouse, and Firehouse building at the June 29, 2020 Special Meeting.

SUMMARY		

The first pay application from BAR Construction dated September 30, 2020 was processed in the amount of \$254, 900.44. Also, due to some proposed modification, there will be a requested change order to include the following additions/modifications to the project: - Ballistic panels to the outer face of the walls around the customer service counter - the location of the hallway entry door has been revised to improve staff safety and to facilitate for better access to printers and IT equipment, this includes permanent closure of a window in the

Server Room (Brick) - additional space added to the ROD Registrar office as well as several IT drops to ensure proper connectivity - added a Vault Clean Agent Fire Suppression System
