The Wayne County Board of Commissioners met on Tuesday, May 19, 2020 at 9:08 a.m. in the Commissioners Meeting Room in the Wayne County Courthouse Annex, Goldsboro, North Carolina, after due notice thereof had been given.

Work Session

During the scheduled briefing and prior to the regularly scheduled meeting, the Board of Commissioners held an advertised work session to discuss the items of business on the agenda.

Call to Order

Chairman E. Ray Mayo called the meeting of the Wayne County Board of Commissioners to order.

Invocation

Commissioner George Wayne Aycock, Jr. gave the invocation.

Pledge of Allegiance

Commissioner William H. Pate led the Board of Commissioners in the Pledge of Allegiance to the Flag of the United States of America.

Approval of Minutes

Upon motion of Commissioner William H. Pate, the Board of Commissioners unanimously approved the minutes of the regularly scheduled meeting of the Board of Commissioners on May 5, 2020.

Discussion/Adjustment of Agenda

Upon motion of Commissioner William H. Pate, the Board of Commissioners unanimously approved and authorized the May 19, 2020 adjusted agenda. Added/Removed:

Discussion of Budget Work Session

County Manager Craig Honeycutt explained the upcoming work session and the need for a Public Hearing on June 2, 2020 at 9:30 a.m., to allow the public to comment on the Proposed Budget.

Motion to Adopt Resolution #2020-19: A Resolution Adopting the Neuse River Basin Regional Hazard Mitigation Plan. A copy of the plan can be reviewed at http://www.neuseriverhmp.com/

Planning Director Berry Gray presented the Neuse River Basin Regional Hazard Mitigation Plan, portions of which are attached hereto as Attachment F. The full version can be viewed at http://www.neuseriverhmp.com/.

Upon motion of Commissioner William H. Pate, the Board of Commissioners unanimously approved adopting the Neuse River Basin Regional Hazard Mitigation Plan.

County Manager's Comments

County Manager Craig Honeycutt introduced Ken Stern for a COVID-19 update. Mr. Stern said Wayne County had 867 cumulative cases, with 248 active cases and 16 deaths. He said they are tracking outbreaks at all congregate facilities and assisted living facilities, including O'Berry Center, Cherry Hospital, Genesis, Brookdale, and others. His department is doing contact tracing with at least ten individuals working that aspect. He also stated 603 COVID positive patients have recovered.

Vice-Chairman Joe Daughtery asked about testing sites and the requirements for testing. Mr. Stern stated, if an individual has a private provider, the doctor can test an individual even if they are asymptomatic. He said state labs will only test symptomatic individuals from hospitals, the healthcare field, 1st Responders, uninsured, those who have symptoms and it is deemed necessary for safety reasons, and post-mortem cases. He said testing supplies are increasing.

Chairman E. Ray Mayo asked if the County numbers are still climbing. Mr. Stern said there are new cases daily and the numbers will continue to climb as the testing increases.

Commissioner William H. Pate asked if outbreaks at certain meat processing plants are caused by employees seeing their co-workers outside of work instead of contact at work. Mr. Stern said the cases are not just with the employees, as family members of the workers are testing positive as well.

Mr. Stern answered additional questions from the Board.

County Manager Craig Honeycutt presented Mr. Stern with a plaque and thanked him for his service. Ken spoke to the Board, praising his staff at the Health Department for working so well with him during the interim.

County Manager Craig Honeycutt spoke of the courts reopening June 1st and stated a meeting was planned with court officials and County staff to create a plan.

Board of Commissioners Committee Reports and Comments

Commissioner William H. Pate thanked Ken Stern for his service to the County. He stated he had attended a teleconference with the hospital and they said they are beginning to see a flattening of the curve. He said the hospital has enough PPEs and ventilators at this time.

Commissioner Edward E. Cromartie stated he attended a Department of Social Services meeting via teleconference and he was in favor of continuing with electronic meetings in the future, due to the ease and convenience. He thanked Ken Stern for his service and praised his work. Mr. Cromartie also thanked Emergency Management Coordinator Aaron Stryker and EMS Director Dave Cuddeback for their leadership.

Vice-Chairman Joe Daughtery thanked Ken Stern for a great job under extraordinary times and for helping to choose the new director.

Commissioner Adrian Worrell thanked Ken Stern for his work with the County and thanked all volunteers and workers who assured school children were being fed.

Commissioner George Wayne Aycock, Jr. thanked Ken Stern for his leadership and spoke of the Department of Insurance's grant program to provide fire equipment to all

participating volunteer fire departments through a 50/50 grant program. Mr. Aycock thanked everyone who was involved in the late Donald Gray's funeral service and said his family's service to New Hope Volunteer Fire Department totaled over 300 years collectively. He reminded everyone that Donald was former Commissioner Roland M. 'Bud' Gray's son.

Chairman E. Ray Mayo thanked Ken Stern for his leadership and said a good staff begins with a good manager. Mr. Mayo said special legislation for farmers on the road was needed to prevent accidents such as the one that claimed Donald Gray's life. He also talked about the small business webinars through Wayne Community College and said they have been a tremendous help to local businesses. Mr. Mayo also commended Wayne County Development Alliance President Mark Pope and his staff. He stated the Department of Social Services teleconference went well and said the department was in the best shape it has been in in six years and credited Department of Social Services Director Kim McGuire for her leadership.

County Manager Craig Honeycutt presented a list of requested options for the recommended July 1, 2020 budget, attached hereto as Attachment H.

A discussion between County Manager Craig Honeycutt and the Board followed the presentation of the list of options.

Vice-Chairman Joe Daughtery discussed the GWTA charges to the County for no-shows and said it has cost the County approximately \$60,000 in two years. He asked the Board to give the County Manager permission to stop the penalty to the County and let individual departments handle the fees from GWTA. The Board members individually agreed for County Manager Craig Honeycutt to pursue the matter.

The Board discussed School Resource Officers (SROs) and who pays for their salaries. Assistant Budget Officer Janice Rise stated the County receives \$710,000 annually in grants and subsidizes the amount with an additional \$600,000 annually.



Date: April 23, 2020

Deputy Garrison Nance has plans to retire from the Wayne County Sheriff's Office on June 1, 2020 (last day May 30). Deputy Nance has had a rewarding career with the Sheriff's Office and has been a valuable asset to the office.

In accordance with NCGS 20-187.2 (a), I am requesting that Deputy Nance be allowed to keep the badge worn and carried by him. The statute provides that there is no cost to be incurred for the badge. Additionally, I also request that Deputy Nance be awarded his service side arm upon his retirement. Deputy Nance is not ineligible to own, possess, or receive his service side arm under the provisions of State or Federal law. The costs associated with the presentment of the service side arm will be paid by the Sheriff's Office if necessary.

20-187.2. Badges and service side arms of deceased or retiring members of State, city and county law-enforcement agencies; weapons of active members.

- Surviving spouses, or in the event such members die unsurvived by a (a) spouse, surviving children of members of North Carolina State, city and county lawenforcement agencies killed in the line of duty or who are members of such agencies at the time of their deaths, and retiring members of such agencies shall receive upon request and at no cost to them, the badge worn or carried by such deceased or retiring member. The governing body of a law-enforcement agency may, in its discretion, also award to a retiring member or surviving relatives as provided herein, upon request, the service side arm of such deceased or retiring members, at a price determined by such governing body, upon determining that the person receiving the weapon is not ineligible to own, possess, or receive a firearm under the provisions of State or federal law, or if the weapon has been rendered incapable of being fired. Governing body shall mean for county and local alcohol beverage control officers, the county or local board of alcoholic control; for all other law-enforcement officers with jurisdiction limited to a municipality or town, the city or town council; for all other lawenforcement officers with countywide jurisdiction, the board of county commissioners; for all State law-enforcement officers, the head of the department.
- (b) Active members of North Carolina State law-enforcement agencies, upon change of type of weapons, may purchase the weapon worn or carried by such member at a price which shall be the average yield to the State from the sale of similar weapons during the preceding year.
- (c) For purposes of this section, certified probation and parole officers shall be considered members of a North Carolina State law enforcement agency. (1971, c. 669; 1973, c. 1424; 1975, c. 44; 1977, c. 548; 1979, c. 882; 1987, c. 122; 2013-369, s. 19; 2016-77, s. 9(b).)

- 1. The United States Air Force (Air Force) has prepared a Draft Environmental Assessment (EA) and Proposed Finding of No Significant Impact (FONSI) evaluating the potential environmental impacts associated with the proposed Combat Air Forces contract adversary air (ADAIR) in support of Seymour Johnson Air Force Base (AFB), North Carolina. The Draft EA was prepared in accordance with the National Environmental Policy Act (NEPA) of 1969, the Council on Environmental Quality regulations implementing NEPA, and the Air Force NEPA regulations.
- 2. The Proposed Action is to contract the support of approximately 2,590 ADAIR sorties annually using 14 contractor-owned and contractor-operated aircraft. Contract ADAIR would support Seymour Johnson AFB training operating out of Kinston Regional Jetport (ISO). Aircraft would depart from the airport runway, transit from the airport to military special use airspace, perform ADAIR training, transit back, and land at the airport. Training activities would use existing special use airspace near Seymour Johnson AFB. Operations and maintenance facilities would be contracted by the service provider at ISO to support the ADAIR mission.
- 3. Executive Order 12372, *Intergovernmental Review of Federal Programs*, requires federal agencies to solicit federal agency as well as state and local government participation in the NEPA process. We are requesting your participation in the review and comment process. The Draft EA and the Proposed FONSI are available at https://www.seymourjohnson.af.mil/Home/SJAFB-Environmental-Management/. Please provide comments on the Draft EA and Proposed FONSI within 30 days of receipt of this memorandum to Cathryn Pesenti at 4 CES/CEIEA, 1095 Peterson Avenue, Seymour Johnson AFB, North Carolina 27531, by electronic mail to cathryn.pesenti@us.af.mil, or by phone at (919) 722-7455.
- 4. The Air Force is aware of the potential impact of the ongoing coronavirus (COVID-19) pandemic on the usual methods of access to information and ability to communicate, such as the mass closure of local public libraries and challenges with the sufficiency of an increasingly overburdened internet. The Air Force seeks to implement appropriate additional measures to ensure that all interested stakeholders

WHEREAS, the Department has approved a grant of funds to the Sponsor under the State Block Grant Program Non-Primary Entitlement funds.

WHEREAS, the Sponsor has made a formal application dated APRIL 28, 2020 to the Department for Non-Primary Entitlement funds for the WAYNE EXECUTIVE JETPORT; and

WHEREAS, a grant in the amount of \$71,890 as allocated on the attached cover letter or any subsequent cover letters (if applicable), not to exceed 90 percent of the federal share of the final, eligible project costs of \$79,878 has been approved subject to the conditions and limitations herein; and

WHEREAS, the Non-Primary Entitlement funds will be used for the following approved project:

APRON PAVEMENT REHABILITATION (design)

NOW THEREFORE, the Sponsor and the Division of Aviation ("Division") do mutually hereby agree as follows:

- 1) Work performed under this Agreement shall conform to the approved project description. Any amendments to or modification of the scope and terms of this Agreement shall be in the form of a modified grant mutually executed by the Sponsor and the Division, except that an extension of time and/or a reallocation of funds within the approved budget may be granted by the Division by written notice to the Sponsor. - 2) The Sponsor certifies that it has adhered to all applicable laws, regulations, and procedures in the application for and Sponsor's approval of the Agreement.
- 3) The Sponsor agrees to comply with the "Sponsor's Assurances" contained as a part of this Agreement. The Sponsor shall be liable to the Department for the return of all grant monies received in the event of a material breach of the Sponsor's Assurances or this Agreement.
