At the direction of the NCSBOE, Debbie Formyduval shared the following statement: *In a Primary Election, unaffiliated voters have the option to choose a Republican, Democratic, Libertarian, or Nonpartisan ballot style, if available. Certain unaffiliated voters who voted in the primary did not have their chosen ballot annotated on their authorization to vote document, which is required practice when unaffiliated voters choose a ballot style. This was an inadvertent poll worker error, and it does not in any way affect whether affected voters' ballots were counted, affected voters' eligibility to vote in this election or future elections, or to vote totals. To address this issue, each affected voter's voter history will reflect that the voter voted a nonpartisan ballot style. Affected voters may make a written request to have their record updated if they believe it is incorrect:*

A motion was made by Steven Mullenix to accept the results of the March 03, 2020 election, seconded by Henry Durham and duly passed to submit to the NCSBOE final results. Note-At this time the Director finalized election results and printed the Canvass Cover Sheet from Election Reporting and board members signed including the BOE notary.

**DIRECTORS REPORT  
WARREN COUNTY BOARD OF ELECTIONS

**ELECTION PROGRAMMING**-Our office continues to plan for November 03, 2020 as best we can with limited information about any changes which the NCSBOE may implement. During this period, staff members have reviewed various election systems including mail absentee ballot processes that will streamline work for our staff. In addition, we have been in touch with vendors including EVID (Electronic Poll books), to obtain information about changes that they expect to implement. We have been actively engaged in better organizing our office and new equipment storage area. Our staff has been engaged with NCSBOE personnel in planning for COVID-19 impact on the election cycle and how we can best serve voters both during the early voting period and on election day. We have established COVID19 guidelines for the upcoming filing period for Soil and Water Conservation District Supervisor. Staff have completed online security training with the "Security Mentor" through the SBOE. Robin has mailed out to commitment letters to precinct officials for the November 3, 2020 Presidential Election. At this time, we have received about 1/3 of the responses back in our office. To date no one has indicated that they are unable to serve due to COVID-19. I have reached out to Warren County manager Vincent Jones regarding opening for county facilities to the public. He indicated that Warren County personnel are working on a plan that will be shared in the near future. Our office will reopen to the public using county guidelines for other local government offices. Updates have been completed on one stop laptops.

**COUNTY FINANCE**: Payables have been coded and forwarded to the county finance office. Budget Tracking was completed and forwarded to county finance and county manager for May. I have followed closely the budget process and currently the only thing that has been removed from the BOE budget is a portion of the travel funds. Travel was reduced across the board with all county agencies in an effort to maintain current spending. I recently purchased a shield for Robin's desk to limit public contact. Under the COVID-19 bill now in the NC Senate, county boards will be reimbursed for the purchase of these items. More information is expected in an upcoming numbered memo from the SBOE Executive Director.

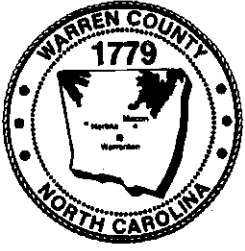

### GUIDELINES FOR FILING PERIOD FOR SOIL AND WATER DISTRICT SUPERVISORS AMIDST COVID-19

As the Warren County Board of Elections prepares for the filing period for candidates for Soil and Water Conservation District (June 8, 2020-July 7, 2020), the NCSBOE has provided guidance and our office is working to ensure that we are prepared and ready amidst COVID-19 concerns: Please know that:

*Our staff is currently wiping down all surfaces and cleaning tables, door handles and other contact areas that visitors may encounter.*

*Social distancing will be marked on floors and entrances and we would ask that the public be mindful of signage as well as markings on the floors and entrances to the BOE office.*

*Be prepared to have your temperature checked as you enter the office. Mask are available if needed.*
