

ISSUE CONSIDERED:	Water & Sewer Upgrades for Eastern Avenue
<p>SUMMARY OF ISSUE: The Town has received pricing from Barnhill Contracting Company for upsizing the water main pipe from 12" to 16" along Eastern Avenue from Regency Drive to Red Oak Road, and for constructing sanitary sewer lines from the south side of Eastern Avenue to the north side between Regency Lift Station to Kamlar Drive. The NCDOT is having Barnhill construct an 8" sanitary sewer line along Eastern Avenue to provide sewer for the commercial buildings in the 2000 and 2100 block of Eastern Avenue as part of the Eastern Avenue Widening Project.</p> <p>The cost of upsizing the water main pipe is \$136,071 plus \$5,263 for engineering for a total of \$141,344. The cost of three 8" sanitary sewer main crossings is \$164,880 plus \$6,377 for engineering for a \$171,257 or \$57,085 per crossing. The three sewer crossings would provide sewer service to Woda Cooper Company's proposed 55-unit apartment building, East Coast Equipment Partners i.e. the John Deere dealership, and David Rose's 60 acres of land between Woda's proposed apartment building and the John Deere Dealer.</p>	
MANAGER'S RECOMMENDATION:	Approve Increasing the Size of the Water Main to 16" and Consider Sharing in the Cost of Sewer Crossing with the Property Owners.

Utility Design

HDR Engineering, Inc., of the Carolinas (HDR) to perform additional preliminary and final design services for associated with the Town of Nashville's request for betterments of the gravity sanitary sewer along SR1770 (Eastern Ave) (between Kalmar Road and a manhole located just east of Forest View Drive). Construction drawings and sewer main special project provisions will be prepared and conform to the Town of Nashville - Standard Specifications & Construction Details (latest version).

HDR will perform sanitary sewer extension permitting through the North Carolina Department of Environmental Quality (NCDEQ) and Town of Nashville. The sewer line betterments as requested by the Town of Nashville will include preliminary and final design services for the following:

Construction Drawing and Technical Specification Development

1. Increasing the water main pipe size from 12" to 16" from Regency Drive to Red Oak Road along Eastern Avenue.
2. An 8" water main crossing near station marker 32+50 with a gate valve and fire hydrant. *Between Glover's 5th & 6th Commercial Bldg for Fire Protection.*
3. An 8" water main crossing near station marker 15+00 with a gate valve and fire hydrant. This water main can be used to provide water services for the Joe Keel property at 2199 Eastern Avenue and Julie Howard property at 2225 Eastern Avenue who are losing their shared well to the road widening project.
4. An 8" water main crossing near station marker 6+50 with a gate valve and fire hydrant. *To replace the existing Fire Hydrant on S. side of Eastern Ave.*
5. An 8" water main crossing near station marker 1+50 with a gate valve and fire hydrant. This water main can be used to replace the existing water service lines for the Kirby Winstead property at 101 Forest View Drive and Brian Pullen property at 100 Forest View Drive.
6. A 4" sanitary sewer service line for the JRS Partners, Inc. property, aka Market Leader Realty, at 2090 Eastern Avenue.
7. A 4" sanitary sewer service stub for the Joe Keel property at 2199 Eastern Avenue for future service of the property.
8. A 4" sanitary sewer service stub for the Julie Howard property at 2225 Eastern Avenue for future service of the property.
9. Eight inch sanitary sewer main crossings at Manholes #7, #10, and #14 with a standard manhole on the end of each crossing.

- Preparation and submission of permits not identified in the original Scope of Services
- Payment of Permit Fees, Privileges, and Assurances
- Environmental impacts and assessments
- Wetland and buffer mitigation and documentation
- Sedimentation and erosion control evaluations and design
- Additional water and sewer main alignment design modifications after route selected
- Development of As-Built/Record Drawings
- Construction administration and resident observation phase services
- Any other services not defined in the original Scope of Services

Assumptions

- All work will be performed within NCDOT right of way with NCDOT acquiring PUE as needed.
- Town of Nashville to provide all built-out demand criteria and data (water and sewage)
- Town of Nashville to verify sanitary sewer main size needed.
- No water and sanitary sewer/force main betterments are included outside of those mentioned above.
- NCDOT will coordinate all meetings and with stakeholders (up to two).
