Mayor Owens called the recessed June 17, 2020 meeting to order and Mr. Ayers did a roll call: Mayor Bobby Owens-present; Mayor Pro Temp Selby-present; Commissioner Richie Burke-present; Commissioner Jason Borland-present; Commissioner Collins-via teleconference; Commissioner Eddie Mann-via teleconference; Commission Walker-via teleconference.

DEPARTMENT HEAD REPORTS:

The Department Head reports were given to the Board and are online for the general public to review and encourages everyone to look at them to see what the Departments having been doing.

PRESENTATIONS-Community Gardens by Michelle Lewis-Manteo and gave a slide show presentation. The Peace Garden Project started in New York and she gave background on how this started. At a church she was pastoring they started planting gardens and saw it as a way to connect the community. We not only grow healthy food we grow healthy communities. We have 6 gardens underway here on Roanoke Island. We partnered with local people and businesses that had extra property. It is not your typical community garden where you get a section of land and grow food for your own use; this is where the community plants the garden and the food is distributed to those in need. They are trying to eradicate the shame of food insecurity. 21% of people in Dare County are food insecure and what that means is there is some portion of the month where there is a lack of available sources of financial aid for food at the household level. We do not make people fill out waivers to prove that they are poor, if people show up and it is harvest day and they want a share of the food we just give them food. We are also working on a model so that it could be income generating in some way. They are a 501C3 and recognized as a non-profit. They have received a grant from the Leadership Institute and have 8 students they

are working with from Manteo and teaching them leadership skills and growing food; there is a spirituality component that they can opt into. Our Mission is to not only grow healthy foods but healthy communities. They also do workshops on racism, immigration, understanding homosexuality; we believe a lot of the problems in our society is due to lack of understanding. A slide was shown of the Board of Directors who not only work with this community but in New York. The students who are part of our Leadership Institute do get an education stipend of \$100-\$200 per week for the work they are doing. Working the gardens also has a healthy aspect to it, helps with self-esteem, physical activity, mental health and has been shown to help with the crime rate. It takes about \$800 a student to sponsor our youth in the summer youth program, they have had to turn students away because they did not have enough funds to sponsor those who wanted to be in the program. They also have 2 students from Duke University who are working with them this summer as virtual interns.

Commissioner Walker-loves the whole concept; how can we get the word out for what they are doing. Ms. Lewis commented we have a website; Facebook page and Instagram page. This is our 4th growing season and grown a ton of food to give to people in need. Another thing is if you know anyone who has land that they are not using have them contact us. The more gardens you have the more youth you will be able to engage and families you can feed. Commissioner Selby asked if the grant they have specifically for Manteo and does it cover the 8 students attending. Ms. Lewis commented that the grant they have received is specifically for Dare County and it almost covers the students that they have. We have raised some money through a mask project they had going on; we have a handful of people making masks and accept donations for those in Dare County, outside of the County they charged for those. Generally, the money raised in a community stays in that community and if anyone wants to sponsor a student, we will graciously accept that donation and it is tax deductible. Commissioner Collins asked how many kids in the program. Ms. Lewis responded we have 8 kids; 3 Latino students; 2 African American students and 2 more sending in applications; 4 white students and 2 other white students we have accepted in the program that we will have to raise money for. Commissioner Selby asked the age group and was told ages 12 through 18. For more information go to Peacegardenproject.net

Clint Helper, Devon Street-"I cannot attend the town Commissioners Meeting tonight, but I'd like to voice favorably for allowing marinas to have boat lifts, just like they are allowed at private docks. A boat small enough to use a lift would not block people's views any more than the flying bridges on larger boats or the masts on sailboats. Don't understand why the Planning troops voted to turn them down!"

Bob Keeney, Fernando Street-written response will be made a part of these minutes and is in favor of allowing boat lifts.

Tracy Pavia, Dartmoor Street-written response will be made a part of these minutes and is in favor of allowing boat lifts.

Mr. Ayers asked for comments from those listening on the teleconference call to please hit *9

#4640-Tim Teeple Fernando Street-does not have an issue with boat lifts but thinks it would make a difference and distract from the view. He also knows that it gives a false sense of security; during a storm, a boat on a lift was not removed and fell and caused major damage. If it does pass hopes, there would be an ordinance passed requiring boats to be removed during a storm. He believes it goes against the land use plan and hopes the Board will listen to the Planning Board and their recommendation to not approve it.

Commissioner Borland-thanked everyone for the peaceful demonstration and was very impressed with Commissioner Collins speech.

Commissioner Collins-the property on Sir Walter Raleigh that the Town owns if it is not sold maybe they could use that for the gardens. Agrees with Commissioner Borland about the peaceful demonstration and the amount of people that showed up.

Commissioner Walker-great idea to use the property on Sir Walter Raleigh St, if it can be worked out.

Commissioner Mann-thanked everyone for the peaceful demonstration and appreciated all the people that showed up. Manteo is about friendship, community and understanding.

Boat Lifts

The Town's zoning ordinance prohibits boat lifts in marinas in Section 12-7(a)(2). The current ordinance was passed on March 5, 2008.

At the April 15, 2020 Board of Commissioners meeting, a Board member suggested the potential deletion of this section of the zoning ordinance.

At the May 6, 2020 Board of Commissioners meeting, the Board referred the matter to the Planning and Zoning Board as required for any text amendment to the zoning ordinances. The Board of Commissioners also set a Public Hearing on the matter for June 17, 2020.

At the May 12, 2020 Planning and Zoning Board, the Board scheduled a public hearing for June 9, 2020.

At the June 15, 2020 Board of Commissioners meeting, a Public Hearing was held. Several comments were received.

Following the Board of Commissioner's Public Hearing one additional public comment was provided and shared with the Mayor and Board of Commissioners.

To lift the prohibition, the following text amendment would be required:

Delete the words "Boat lifts, or any devices attached to pilings or docks and designed to suspend a boat over the water, are not permitted in marinas" from the ordinance text.

2007 Land Use Plan Review:

The 2007 Land Use Plan does not specifically address boat lifts.

The 2007 Land Use Plan does state that "PA Policy 3: New parks and open spaces should be sited and designed to maintain the town's natural edge, protect fragile areas, improve water quality, preserve views to public trust waters, and be in keeping with Manteo's historic character."

Figure 17 (Attachment 1) of the 2007 Land Use Plan designates the views from Marshes Light as "Important Public Views." However, Figure 11 (Attachment 2), which also designates "Important Public Views" does not include Marshes Light.

The Planning and Zoning Board voted to adopt the consistency statement and recommended not changing the ordinance to allow boat lifts in Marinas.

Consistency Statement:

The Town of Manteo Planning and Zoning Board finds the action to amend the zoning ordinance to allow boat lifts in marinas to be inconsistent with the Town's 2007 Land Use Plan. The Town's 2007 Land Use Plan does not specifically mention boat lifts but Public Access Policy 3: states "New parks and open spaces should be sited and designed to maintain the town's natural edge, protect fragile areas, improve water quality, preserve views to public trust waters, and be in keeping with Manteo's historic character."

Recommendation to the Board of Commissioners:

The Planning Board finds action to amend the Town of Manteo's Zoning Ordinance Section 12-7 to be inconsistent with the Town's Land Use Plan per §160A-383, in a 4 to 1 vote, the Planning Board recommends that the Board of Commissioners not amend the Town's Zoning Code Article 12-USE PROVISIONS Section 12-7 Marinas (a) (2).

AN ORDINANCE AMENDING THE ZONING ORDINANCE OF THE TOWN OF MANTEO, NORTH CAROLINA TO ALLOW FOR BOAT LIFTS IN THE SHALLOW BAG BAY SOUTH MARINA AREA (ZTA 2020-05Z)

ARTICLE I. Purpose(s) and Authority.

WHEREAS, pursuant to N.C.G.S. § 160A-381, the Town of Manteo (the "Town") may enact and amend ordinances regulating the zoning and development of land within its jurisdiction and specifically the location and use of buildings, structures and land. Pursuant to this authority and the additional authority granted by N.C.G.S. Chap. 160A, Art. 19 et. seq, the Town has adopted a comprehensive zoning ordinance (the "Town's Zoning Ordinance") and has also codified other ordinance provisions Town in the Town's Code of Ordinances (the "Town Code"); and

WHEREAS, pursuant to N.C.G.S. § 160A-174, the Town may enact and amend ordinances which define, prohibit, regulate, or abate acts, omissions, or conditions, detrimental to the health, safety, or welfare of its citizens and the peace and dignity of the city, and may define and abate nuisances within its jurisdiction; and

WHEREAS, currently the Town's Zoning Ordinance prohibits boat lifts and similar devices in marinas located in the Shallowbag Bay South area, and the Town desires to allow boat lifts and similar devices in that marina area; and

WHEREAS, the Town further finds that in accordance with the findings above it is in the interest of and not contrary to the public's health, safety, morals and general welfare for the Town to amend the Town's Zoning Ordinance and Town Code of Ordinances as stated below.

ARTICLE II. Construction.

For purposes of this ordinance amendment, underlined words (<u>underline</u>) shall be considered as additions to existing Town Code language and strikethrough words (<u>strikethrough</u>) shall be considered deletions to existing language. Any portions of the adopted Town Code which are not repeated herein, but are instead replaced by an ellipses ("...") shall remain as they currently exist within the Town Code.

ARTICLE III. Amendment of Zoning Ordinance

NOW, THEREFORE, BE IT ORDAINED by the Town Board of Commissioners of the Town of Manteo, North Carolina, that the Town's Zoning Ordinance be amended as follows:

PART I. That **Sec. 12-7(a)(2)** of the Zoning Ordinance, Town of Manteo, North Carolina, is hereby amended to read as follows:

(2) Shallowbag Bay South (south of the NC Maritime Museum). This area historically has been the site of traditional watermen activities such as crabshedding, oystering, and wooden boat building. These uses are still encouraged even as the primary use shifts toward private, recreational boating. Further development of this area for commercial charter boats is not allowed. Boat lifts, or any devices attached to pilings or docks and designed to suspend a boat over the water, are not permitted in marinas.

ARTICLE IV. Statement of Consistency with Comprehensive Plan and Reasonableness.

The Town's adoption of this ordinance amendment is consistent with the Town's adopted comprehensive zoning ordinance, land use plan and any other officially adopted plan that is applicable. For all of the above-stated reasons and any additional reasons supporting the Town's adoption of this ordinance amendment, the Town considers the adoption of this ordinance amendment to be reasonable and in the public interest.

ARTICLE V. Severability.

All Town ordinances or parts of ordinances in conflict with this ordinance amendment are hereby repealed. Should a court of competent jurisdiction declare this ordinance amendment or any part thereof to be invalid, such decision shall not affect the remaining provisions of this ordinance amendment nor the Zoning Ordinance or Town Code of the Town of Manteo, North Carolina which shall remain in full force and effect.
