## A. PROPOSED BUDGET FOR FISCAL YEAR 2021

In accordance with the N.C. General Statutes 159-12(b), the Rutherfordton Town Council will hold a public hearing on the proposed budget for the fiscal year 2021 on Wednesday, June 3, 2020, at 5:30 p.m. or soon thereafter in the Town Council Chambers at the Rutherfordton Town Hall, 129 North Main St, Rutherfordton NC. The purpose of the hearing is to receive public input for the proposed budget for the fiscal year beginning July 1, 2020. All interested citizens are invited to attend the hearing & submit comments. In order to adhere to North Carolina Governor Cooper's order to limit gatherings to no more than 10 people and to stay at least 6 feet apart, after making your public comment you may be requested to leave the Rutherfordton Town Hall to permit others waiting outside to come in.

A copy of the proposed budget was submitted to the Town Council at their meeting on May 6, 2020 and is on file in the Town Clerk's Office available for public inspection from 8:00 a.m. to 5:00 p.m., Monday through Friday and also on the website for the public to view.
